

Albaron Partners Privacy Policy

1. Scope

This Privacy Policy describes how Albaron Partners and its affiliated investment funds and management entities, including Albaron Healthcare Opportunities I LP (collectively, “Albaron,” “we,” “us,” or “our”), collect, use, and disclose personal information through the website located at albaronpartners.com (the “Site”) and in connection with Albaron’s business communications, including its SMS Messaging Communications Program. By using the Site or providing personal information to Albaron, you acknowledge and agree to the practices described in this Privacy Policy.

2. Information We Collect

Albaron collects information that individuals voluntarily provide, such as name, email address, telephone number, employer, title, and any other information submitted when contacting us or opting in to receive communications, including SMS messages. Albaron may also automatically collect certain technical information when the Site is visited, such as IP address, browser and device characteristics, pages viewed, and similar usage data, which may be collected through cookies and similar technologies.

3. How We Use Information

Albaron may use personal information for any legitimate business purpose, including to respond to inquiries; to communicate regarding Albaron, its funds, and its portfolio companies; to operate the SMS Messaging Communications Program; to evaluate potential investments, transactions, and business relationships; to comply with legal, regulatory, and contractual obligations; and to operate, secure, and improve the Site.

4. SMS Messaging Communications Program

Participation in Albaron’s SMS Messaging Communications Program is voluntary and opt-in. Message and data rates may apply, and message frequency varies. Participants may unsubscribe at any time by replying STOP and may reply HELP for support or more information. **Text messaging originator opt-in data and consent will not be shared with or sold to third parties or affiliates for marketing purposes.**

5. How We Share Information

Albaron does not sell personal information. Except as provided in Section 4 with respect to SMS opt-in data and consent, Albaron may disclose personal information to its affiliates; to service providers performing services on Albaron’s behalf; in connection with any actual or contemplated financing, investment, reorganization, or other corporate or fund transaction; as required or permitted by

applicable law, regulation, legal process, or governmental request; and where Albaron believes disclosure is appropriate to protect the rights, property, or safety of Albaron or others.

6. Security and Retention

Albaron maintains safeguards that it considers reasonable to protect personal information. However, no method of transmission or storage is completely secure, and Albaron does not and cannot guarantee the security of any information. Albaron retains personal information for as long as it considers necessary or appropriate for the purposes described in this Privacy Policy or as required by applicable law.

7. Third-Party Websites

The Site may contain links to websites operated by third parties, including LinkedIn. Albaron is not responsible for the privacy practices or content of any third-party website, and this Privacy Policy does not apply to them.

8. Children

The Site and Albaron's communications are not directed to individuals under the age of 18, and Albaron does not knowingly collect personal information from children.

9. Changes to This Privacy Policy

Albaron may modify this Privacy Policy at any time in its sole discretion. Changes are effective upon posting to the Site. Continued use of the Site or continued participation in Albaron's communications programs following any change constitutes acceptance of the revised Privacy Policy.

10. No Rights Created

This Privacy Policy is a statement of Albaron's current privacy practices. It is not a contract and does not create any legal or contractual rights or obligations in favor of any person.
